The Canadian School Boards Association (CSBA) is seeking contracted support for the development and facilitated delivery of a national advocacy event based in Ottawa during early October 2023. General parameters include:

- The work will begin immediately and continue until the event has taken place and an evaluation report has been submitted to the CSBA.
- The successful contractor will ideally have experience in working with governing boards, with advocacy at the federal government level, and the demonstrated ability to plan and facilitate face-to-face advocacy events involving senior elected officials.
- The successful contractor will have an understanding of the role and value of school boards and the shared jurisdictions of governing school boards and specific federal ministries.
- The target date for the event or series of events is October 2-5, 2023.
- Timing for the events will take into consideration House and Senate sittings as well as the availability of specific MPs and Senators.

Background:

- The CSBA represents provincial school board associations and is the national voice for school trustees throughout Canada.
- Advocacy at the federal level is one of the strategic priorities of the CSBA.
- The mandates of numerous federal ministries overlap with the jurisdiction of governing school boards, including Indigenous Services, Health, Public Safety, Crown-Indigenous Relations and Northern Affairs, Youth, Democratic Institutions, Official Languages, Telecommunications, and Canadian Heritage.
- The key focus areas of our federal level advocacy include:
 - Fair Dealing and copyright legislation
 - National food programs for children and youth
 - Youth mental health programs and services
 - Internet connectivity in remote and rural communities
 - Teacher recruitment and immigration especially for French as a Second Language
 - Minority language rights and supports
 - Truth and Reconciliation as well as Indigenous services
- CSBA has identified specific strategic issues / priorities on which to focus our 2023 advocacy efforts including this event.
- Successful face-to-face events were held in May 2019 and 2022, with virtual events in 2020 and 2021 (due to Covid). 2023 will be face-to-face.

The Opportunity:

- The Contractors(s) will report to the CSBA Executive Director and provide support to the CSBA Executive Committee and our Board of Directors.
- The work will involve planning and delivery of all details related to the event(s):
 - 1. Identification of a detailed work plan, including targeted contacts and detailed planning of in-person meetings and related communications, taking onto consideration the targeted topics provided by CSBA.
 - 2. Development of issue and event briefing materials for the members of the CSBA Board of Directors.
 - 3. Development of 'asks' and messaging for the Advocacy Event meetings.
 - 4. Coaching and strategic advice for the Board of Directors.
 - 5. Post-mortem overview report and follow-up thank you letters.

Proposals:

- Your written proposal must include the following components:
 - o An overview of your advocacy experience and expertise.
 - Brief bio(s) of the contractor(s).
 - o Summary of services available.
 - o Sample Plan/Proposal.
 - Overview of your recommended approach for the advocacy event.
 - Compensation expectations, including expenses.
