In October 2025, the Board of Directors met with federal elected officials and senior leaders in Ottawa to discuss shared priorities regarding public education. The areas of focus included raising awareness of the importance of sustainable funding for the National School Food Program, promoting comprehensive school health, and the importance of supporting Indigenous, First Nations and Metis learners. Finally, conversations with representatives reinforced the importance of including local school Board voices in decision-making conversations about expanded infrastructure projects in communicates.

The CSBA is excited to announce a new logo to represent our organization. The journey to develop this new visual identity was taken collaboratively by our Board of Directors. Feedback received during the development process called for elements that represented student growth and success, unity and collaboration, and the vibrant diversity of Canadian youth that CSBA serves and represents. In the end, the Board agreed to adapt the logo representing three overlapping “C’s”.

Featuring three overlapping “C”s of gradually larger sizes, it represents students at distinct stages of their learning journeys; from their early and middle years through to senior grades and graduation. The transparent, overlapping colours symbolize strong unity of the CSBA’s cross-Canadian membership and the beauty of diversity. Finally, the aperture-like arrangement reflects a focus on students, keeping their well-being at the center of CSBA’s advocacy.

Strategic Plan: 2026–2030 Updates

The 2026-2032 Strategic Plan was brought forward for review and approval by the Board. The presented plan incorporated suggestions from two previous rounds of edits. The strategic plan aims to reflect both continuity and evolution — drawing on the lessons of the past while charting a bold, inclusive future.

The Executive Director will now use this Strategic Plan as a guide in developing the CSBA’s operational plan. This operational plan will include specific actions for each year to be built on over the next six years and best support the three priorities outlined in the strategic plan.

The new strategic plan defines the CSBA’s mission and vision as follows:

Mission: To champion publicly funded, democratically governed education by supporting elected local school board associations in their leadership, advocacy, and commitment to equity, reconciliation, and well-being.

Vision: A country where democratically elected local school boards lead inclusive, responsive, and equitable public education systems, enabling every learner to thrive and every community to be represented.

The strategic plan further defines three intersecting priorities that will define and guide the CSBA’s ongoing collective work:

- Advocacy and Public Leadership,
- Reconciliation and Indigenous Partnerships,
- Contextualizing Education within Health and Wellness.

Pollock Report Follow-Up

The Board continues to review the progress on various items that were actioned following the Pollock report, following the application of recommendations at the jurisdictional and national levels. There has been good progress made on a number of recommendations in the individual member jurisdictions, and the Board is actively reviewing these to consider how they can now be applied at the national level. All recommendations from the report were considered in the production of the 2026-2032 Strategic Plan to ensure we continue to make progress on them as part of our strategic and operational goals.

Committee Updates

INDIGENOUS EDUCATION COMMITTEE

The Indigenous Education Committee is implementing a Cross Canadian jurisdictional survey to identify the resources, tools, and approaches being used across jurisdictions to support the success of Indigenous learners. The survey questions were approved for use at the October Board meeting and will be sent to CSBA's member organizations to participate. The information will be collated for presentation in the July 2026 Trustee Gathering in Whistler, BC.

GOVERNANCE COMMITTEE

The Governance Committee brought several revisions to be made to policies in order to clarify the role of President and Vice-president in relation to orienting new CSBA Board members. The Board remains committed to strengthening internal relationships to strengthen the Association's national voice and will continue to examine other governance structures to reinforce the work of CSBA.

The number of school boards across Canada who are participating in the Putting Data to Work – Faisons parler les données initiative is expanding! There are currently 26 school boards participating. Data from the 2023-24 and 2024-25 school years is continuing to be uploaded and finalized, with complete data sets from more than 16 school boards so far. This fall, a new engagement campaign has been launched for Francophone school boards. Further resources for technical teams are also being developed and shared with boards as they join the initiative, helping make the initiative accessible to as many boards as possible. It is exciting to see the work on this initiative advance!
